Mr. John Yau: *Project Director of Hong Kong Greenlink Kusters Co. Ltd*

Mr. Yau is a Qualified Civil Engineer. In 2001 Mr. Yau went to Germany where he gained his green roof knowledge. Since then, Mr. Yau has been promoting green roof concept to both private and government sectors in Hong Kong. Over the years, Mr. Yau has been invited from time to time by Governments, Institutions, Landscape Architects, Architects and Engineering firms to share his green roof knowledge and related experience. Mr. Yau is one of the few Green Roof experts in Hong Kong who focuses on Extensive Green Roof System. This system uses a special succulent green roof plant, "Sedum", which survives with low water in-take and hence, minimal maintenance is required. Mr. Yau is currently working on several government projects on soil-less Vertical Green Wall and road-side Green Noise Barrier.
