TOPIC: **Greywater Recycling System for an Academic Institution**

This event will cover the water conservation facilities at The City University:

The City University recently commissioned the HKPC to install a greywater recycling system to reclaim hand-wash effluent from washing basins in toilets and condensate from the central air handling unit (AHU) for irrigation. The patented process used a combination of biological treatment and microfiltration to produce high quality recycled water. This unique form of membrane bioreactor (MBR) was compact and could lower operation cost comparing to common submerged type MBR. The treatment capacity of 7 cu m/hr made the system the largest greywater recycling system in Hong Kong to date.
